## Dangerous Goods Support Service

The Dangerous Goods Support Service is aimed at any organisation who want a Dangerous Goods Specialist on hand for help and advice, or who legally require a DGSA. We offer three levels, Premier Support Service, DG Support Service and Support Service Lite.

So what's Included in each service?

### **Premier Support Service**

Our Premier Support Service includes a dedicated DGSA and DG Expert who will be on-hand to support you and your team throughout the year. It also includes a visit to your facility to conduct a Dangerous Goods Audit which is followed up with a Full Audit Report, as well as a Dangerous Goods Compliance Certificate to prove you have an Appointed DGSA and Annual Reports on file - this meets the legal requirements if you need a formally appointed DGSA.

The Premier Support Service also includes, with no additional fees, a Bespoke In-House Awareness Training Course each year and *in addition* we will also give you two credits to use on any of our open Dangerous Goods Training courses! If the credits are not useful for you, you can opt to swap them for an additional 1-Day in-house training course, the choice is yours.

### **DG Support Service**

This is our classic, and most popular support service and it includes a dedicated DGSA and DG Expert who will be on-hand to support you and your team throughout the year. It also includes a visit to your facility to conduct a Dangerous Goods Audit which is followed up with a Full Audit Report, as well as a Dangerous Goods Compliance Certificate to prove you have an Appointed DGSA and Annual Reports on file - this meets the legal requirements if you need a formally appointed DGSA.

### **Support Service Lite**

This service is aimed at businesses who do not legally require a DGSA but still want ongoing support and it includes a dedicated DG Expert who will be on-hand to support you and your team throughout the year.

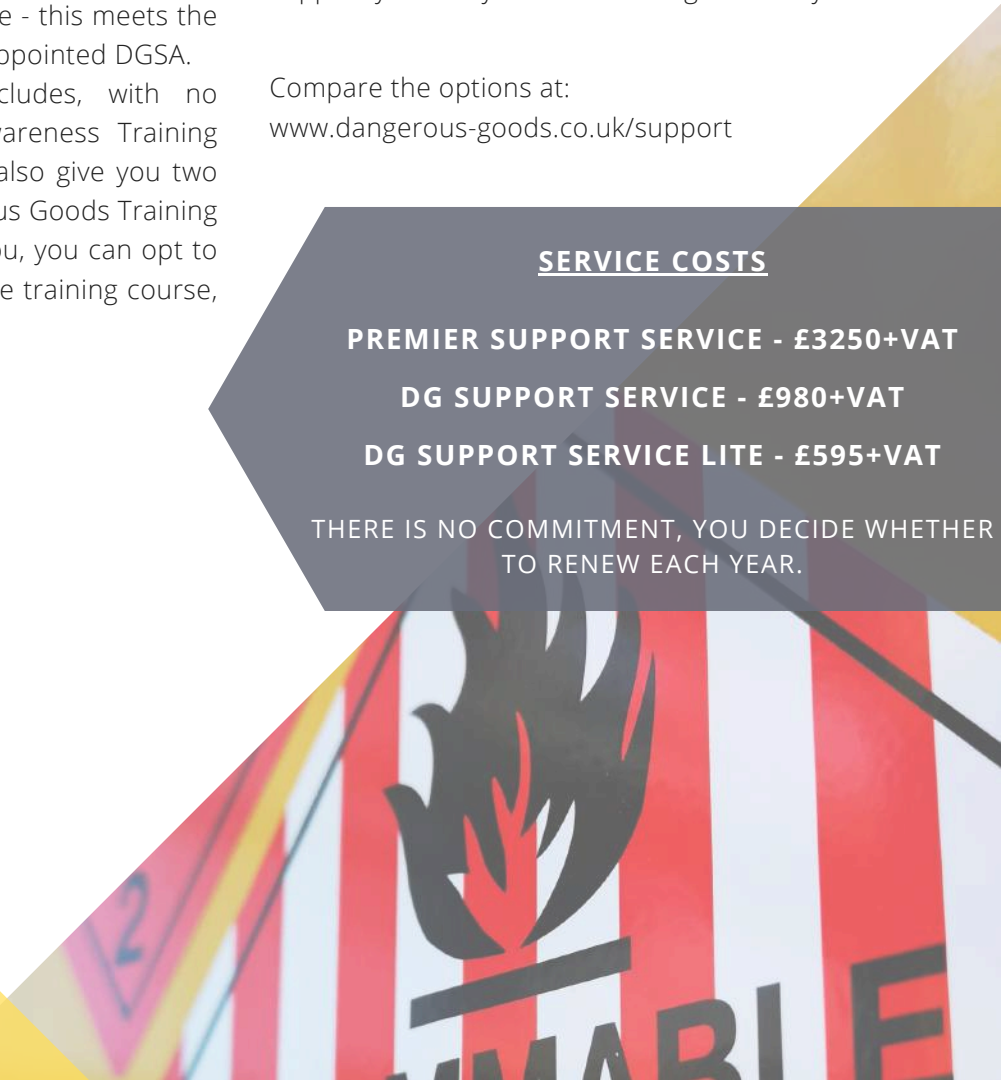
